Ordinance 2108

AN ORDINANCE REGULATING PARKING ON VARIOUS STREETS IN THE BOROUGH OF SOUTH PLAINFIELD, COUNTY OF MIDDLESEX AND THE STATE OF NEW JERSEY AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

WHEREAS, the Borough Police Department has recommended that Parking and Traffic Ordinances be reviewed and revised; and

WHEREAS, the Traffic Safety Advisory Commission has reviewed the recommendation and concurs in same;

NOW, THEREFORE, BE IT ORDAINED by the Borough of South Plainfield, County of Middlesex, State of New Jersey as follows:

Chapters 187, 259, 311, and 455 of the Code of the Borough of South Plainfield shall be and are deleted;

Article I. General.

187-1. Definitions.

A. Whenever any words and phrases are used in this chapter, the meanings respectively ascribed to them in Subtitle 1 of Title 39 of the New Jersey Statutes Annotated (N.J.S.A. 39:1-1 et seq.) shall be deemed to apply to such words and phrases used in this chapter.

187-2. Violations and penalties.

A. Unless otherwise provided by New Jersey statute, for any violation of any Article or Section herein for which a penalty has not been proscribed for violation of such Article or Section, any person convicted of a violation shall be assessed a fine of not less than \$50.00 or more than \$200.00.

187-3. Signs and markings.

A. All traffic signs and markings shall be made and erected in accordance with the "Manual on Uniform Traffic Control Devices for Streets and Highways", current edition.

187-4. Repeal of former ordinances.

A. All traffic ordinances of the Borough of South Plainfield are hereby repealed, and all ordinances or parts of ordinances in conflict with or inconsistent with the provisions of this chapter are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this chapter.

187-5. Official Time Standard.

A. Whenever certain hours are named in this chapter, they shall mean either Eastern Standard Time or Eastern Daylight Savings Time as may be in current use.

187-6. Authorization for the closing of any street.

- A. Pursuant to N.J.R.S. 40: 67-16.9, the Mayor and Council of the Borough of South Plainfield or their designee, is hereby authorized to provide for and promulgate regulations for the closing of any street or portion thereof located in the Borough of South Plainfield to motor vehicle traffic on any day or days or during any specified hours on any day or days whenever the Mayor and Council of the Borough of South Plainfield or designee, find that such closing is necessary for the preservation of the public safety, health or welfare.
- B. Signs conforming to the requirements of N.J.R.S. 40: 67-16.9 shall be posted at the appropriate location at any street or portion thereof which is closed to warn the public of such closing and be posted the entire time that such street or portion is closed.
- C. Any unoccupied vehicle parked or standing in violation of this section of the ordinance shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any police officer may provide for the removal of such vehicle. The vehicle owner shall pay the reasonable costs of the removal before regaining possession of the vehicle
- D. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$48.

187-7. Effect of chapter.

A. If any part or parts of this chapter are, for any reason, held to be invalid, such decision shall not affect the validity of the remaining portions of this chapter.

187-8. Enforcement.

All sections of this ordinance shall be enforced by the Police Department of the Borough of South Plainfield. Each and every day of noncompliance, for any section of this ordinance, shall be considered a separate violation.

Article II. Parking, Stopping and Standing

187-9. No Parking, Both Sides, Entire Roadway.

- A. It shall be unlawful to park, stop or stand any vehicle at any time for the entire length of the roadway on the following locations:

- A. It shall be unlawful to park, stop or stand any vehicle at any time on certain sections in the following locations:
 - 1. Amboy Avenue East side, between Anthony Street and Pulaski Street, Monday thru Friday, 4:00 p.m. to 8:00 p.m.
 - 2. Astor Street North side, from South Clinton Ave to a point 200 feet west.

- 3. Avon Avenue South side, Cady Lane to West Crescent Pkwy
- 4. Cedarbrook Avenue East side between Maple Avenue and Kenyon Avenue
- 5. Carnegie Street North Side, from South Clinton to Parker Avenue
- 6. Century Road
 - a. South side for entire length
 - b. North side from South Clinton Avenue to Rand Road
- 7. Chambers Street
 - a. North side, from Park Avenue to a point 95 feet west
 - b. South Side, from Park Avenue to a point 125 feet west
- 8. Church Street
 - a. North side, Hamilton Blvd to Lakeview Ave
 - b. South side, between 7am-6pm Monday Thru Friday
- 9. Clinton Avenue
 - a. Both sides 500' south of 7th Street

 - a. Both sides from Front Street to a point 105 feet east

- b. Loading zone, from a point 25 feet west of the intersecting curb lines of the northwest corner of South Plainfield Ave and Sacred Heart Drive to a point 75 feet west of the intersecting curb lines of the northwest corner of South Plainfield Ave and Sacred Heart Drive. This area to be designated a loading or unloading zone. Only vehicles actively engaging in loading or unloading of passengers to stop or stand in this location.
- c. Designated handicapped parking area (reserved for future use)

37. St Nicholas Ave -

- a. South side, entire length
- b. North Side from Kennedy Road to South Clinton Avenue
- c. North Side from Kennedy road to a point 100 feet east
- d. North side from Hamilton Blvd to the east driveway of Club at Ricochet, Block 420, Lot 11.021
- 38. Wade Avenue Both sides from South Clinton Avenue to the east driveway of 107 Wade Avenue.
- 39. West End Ave East Side, entire length.
- B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, forfeit and pay a fine of \$48.
- 187-11. No Parking School Days 7:00 a.m. to 9:00 a.m. and 2:00 p.m. to 4:00 p.m.
 - A. There shall be no parking, stopping or standing in the designated areas when school is in session between the hours of 7:00 a.m. to 9:00 a.m. and 2:00 p.m. to 4:00 p.m. During such time, parking, standing or standing shall not be permitted as follows:
 - 1. Chambers Street The both sides from Morris Ave to Murray Street
 - 2. Garibaldi Avenue West side, Harvard Avenue to Tremont Avenue
 - 3. Lake Street The North side from Plainfield Avenue to a point 475 feet east of South Central Avenue
 - 4. Stratford Avenue Entire west side
 - 5. Walter Street
 - a. South side from Mildred Street to Murray Avenue
 - b. North side in school drop off zone between the horseshoe driveway
 - 6. Wickford Road East side from Cromwell Place to Skene Drive
 - B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$48.
- 187-12. No Parking School Days 8:00 a.m. to 4:00 p.m.
 - A. There shall be no parking, stopping or standing in the designated areas when school is in session between the hours of 8:00 a.m. to 4:00 p.m. During such time, parking, standing or standing shall not be permitted as follows:

- 1. Freed Place West side from Middle School to Merchants Ave
- 2. Garden Drive Both sides, Geary Drive to Robert Place

- 3. Geary Drive Both sides from Plainfield Avenue to a point 145 feet east of Garden Dr.
- 4. Gray Drive West side from Franklin Avenue to a point 390 feet south
- 5. Lane Avenue
 - a. Both sides from the High School lot to Merchants Ave
 - b. Both sides from Plainfield Avenue to Pearl Place
- 6. Merchants Avenue
 - a. North side from Lane Avenue to Ritter Avenue
 - b. Both sides from Lane Avenue to a point 375 feet west
- 7. Norwood Avenue East side from South Plainfield Avenue to West Fairview Ave
- 8. Randolph Avenue South Side from Sacred Heart Drive to a point 150 feet east
- 9. Ritter Ave
 - a. East side from the High School parking lot to a point 148 feet South
 - b. West side from Triangle Place to Van Fleet Avenue
- 10. South Central Avenue West side from Lake Avenue to South Madison Drive
- 11. Spring Street Both sides Lane Ave to Ritter Avenue
- 12. Triangle Place From Lane Avenue to Ritter Avenue
- 13. Van Fleet Avenue South Side from Lane Avenue to Ritter Avenue
- B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$48.

187-13. School Bus Loading Zones.

- A. It shall be unlawful to park, stop or stand a vehicle in a designated school bus loading zone within the Borough of South Plainfield at the following locations;
 - 1. Franklin School The north side of Franklin Avenue from a point 472 feet east of Clinton Avenue to a point 645 feet east of Clinton Avenue
 - 2. Grant School The south side of Cromwell Place from a point 57 feet east of Wickford Road to a point 430 feet east of Wickford Road
 - 3. High School The south side of Lake Street from the northwest driveway to its termination at the end of the street
 - 4. Middle School The south side of Lake street from a point 200 feet east of Plainfield Avenue to 701 feet east of Plainfield Avenue
 - 5. Roosevelt School Jackson Ave, West Side from Evona Place to Garibaldi Avenue
- B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$64.

187-14. Two Hour Parking Limit.

- A. It shall be unlawful to park, stop or stand a vehicle for any period greater than two hours within the "marked on-street parking spaces" along Hamilton Boulevard and South Plainfield Avenue.
- B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$48.

187-15. Municipal Parking Lot.

- A. This section shall establish certain areas that are open to the public and which the public is invited as shall prohibit parking in areas designated as *Handicapped Parking Spaces* in the municipal parking lot located at 2480 Plainfield Avenue, in the Borough of South Plainfield, for use by persons who have been issued special identification cards by the Motor Vehicle Commission or who have vehicles that contain proper Handicapped license plates. No other persons are to park in these spaces.
 - 1. Parking spaces designated as Handicapped Parking Spaces shall be marked by signs indicating the handicapped parking spaces, in conformance with the Manual on Uniform Traffic Control Devices for Streets and Highways, current conditions.
- B. This section shall establish certain areas designated as parking for *Police Vehicles Only* and shall be marked with an appropriate sign and/or ground markings indicating these spaces which will be identified by yellow painted lines. These parking spaces shall be designated with the appropriate police vehicle number or Officer Designation when appropriate.
 - Any unoccupied vehicle or standing in violation of this section of the ordinance shall be deemed a nuisance and any police officer may provide for the removal of such vehicle.
 The owner shall pay the reasonable costs of removal and storage which may result from such removal before regaining possession of the vehicle.
- C. This section shall establish certain areas designated as parking for *borough officials, visitors and library staff*. These spaces shall be marked appropriately with signs or ground markings indicating these spaces.
- D. This section shall establish that all other parking spaces located in the parking lot to be open to the *general public*. Vehicles to be parked in appropriate parking spaces and parked between the designated lines. These spaces will be marked with white painted lines.
- E. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$25.

187-16. OEM Parking Lot.

- A. It shall be unlawful to park, stop or stand a vehicle in the OEM building parking lot, 1 South Plainfield Avenue, South Plainfield, NJ 07080 as follows;
 - 1. Establish certain areas designated as parking for *OEM officials only*. These spaces shall be marked appropriately with signs or ground markings indicating these spaces.
 - 2. Establish that all other parking spaces located in the parking lot to be open to the *general public*. Vehicles to be parked in appropriate parking spaces and parked between the designated lines. It shall be unlawful to park, stop or stand a vehicle for any period greater than two hours within spaces appropriately marked as "2 Hour Parking". No vehicles are to park in these marked spaces overnight between the hours of 9 p.m. 7 a.m.

- 3. Vehicles that are not properly parked, unoccupied or standing, will be in violation of this section of the ordinance and may be removed at the order of a Borough Official or police officer.
- B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$25.

187-17. Emergency No Parking.

- A. Upon the declaration of an emergency, there shall be no parking upon streets or portions of streets where temporary EMERGENCY NO PARKING signs are displayed. The Chief of Police or in his absence, the ranking police officer, is authorized to declare an emergency and to direct the posting of said EMERGENCY NO PARKING signs when weather conditions, accidents, fires or public celebrations such as the Labor Day Parade, Junior Baseball Opening Day Parade and the like dictate or require the avoidance of hazards or other conditions which interfere with the free flow of traffic.
- B. Any unoccupied vehicle parked or standing in violation of this section of the ordinance shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any police officer may provide for the removal of such vehicle. The vehicle owner shall pay the reasonable costs of the removal before regaining possession of the vehicle
- C. The effectiveness of this ordinance is contingent on signs being erected as required by law.
- D. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$48.

187-18. Unregistered, uninsured and/or uninspected vehicles.

- A. It is the responsibility of the vehicle's registered owner that no currently unregistered, uninsured and/or uninspected vehicle shall be parked, at any time, on any property within the Borough of South Plainfield.
- B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$130.

187-19. Disassembly or repair of vehicles on a public roadway.

- A. It is the responsibility of the vehicle's registered owner that no motor vehicle shall be in a state of disassembly, disrepair or be in the process of being stripped down or dismantled, at any time, while parked on a public roadway within the Borough of South Plainfield.
- B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$130.

187-20. Regulating parking of commercial vehicles.

A. Definitions. As used in this subsection:

1. *Commercial vehicle* – shall mean and include, but is not limited to, vehicles with the following types of registrations: Commercial, contractor, omnibus, used car dealer and school bus. For the purposes of this section, any vehicle containing advertising matter

intending to promote the interest of any business, or any vehicle used in connection with the New Jersey State Motor Vehicle Commission is considered a commercial vehicle.

- B. Within the Borough of South Plainfield, it shall be unlawful for any person to park a commercial vehicle upon any public street overnight between the hours of 9:00 p.m. and 7:00 a.m.
- C. No commercial vehicle shall be permitted to be parked anytime on any public street within the Borough of South Plainfield except if said vehicle is making deliveries or belongs to a contractor who is employed in doing work at the subject residence.
- D. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$48.

187-21. Regulating parking in front yard setback.

- A. In all zones of the Borough of South Plainfield including every industrial business, institution, recreation, residential or any other use, off street parking shall not be permitted in the front yard setback area except in an area designated for parking which shall be surfaced with asphalt, bituminous, cement or stone.
- B. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, forfeit and pay a fine of \$48.

187-22. Regulating parking of recreational vehicles and trailers.

A. Definitions:

Boat – A watercraft propelled by oars, paddles, sail or power.

Camper – A separate vehicle designed for human habitation and which can be attached to or detached from a motor vehicle.

Camper/trailer - A vehicular, portable dwelling structure deigned to be used for recreational purposes. This includes a travel trailer, so identified by the manufacturer, a pickup camper, a folding tent trailer, a motorized camper where the camper portion is an integral part of the self-propelled vehicle.

Motor home – A self-contained vehicle designed for human habitation with its own motive power and with a passageway from the body of the home to the driver's and front passenger seat.

Trailer - A vehicle without motive power designed for carrying persons or property on its own and to be drawn by a vehicle with motive power. The term "trailer" shall include but shall not be limited to horse trailers, boat trailers, skimobile trailers, landscape trailers, construction trailers and car trailers.

- B. No person, firm or corporation shall park a recreational vehicle upon any road, street or highway within the Borough of South Plainfield.
- C. No person, firm or corporation shall park a trailer, attached or unattached to a motor vehicle, upon any road, street or highway within the Borough of South Plainfield *except* if said trailer is making deliveries or belongs to a contractor who is employed in doing work at the subject residence.

- D. No person, firm or corporation shall park a trailer, attached or unattached to a motor vehicle, upon any road, street or highway overnight within the Borough of South Plainfield.
- E. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$55.

187-23. No parking within 30 feet of a commercial building, commercial store or public school in designated fire zones.

- A. Pursuant to the provisions of N.J.S.A. 40:48-2.46, no person shall park, stop or stand any vehicle at any time within 30 feet of any commercial store structure, or in any area so designated as a fire zone, with the appropriate signs posted, known as:

- B. All of the land area described in section A above is hereby designated as a "No Parking" zone or "Fire" zone.
- C. Signs shall be erected designating the No Parking Zones and Fire Zones, and placed and maintained as required by the Commissioner of Transportation.
- D. Any person or persons who violate any provision of this section of this ordinance shall, on conviction thereof, pay a fine of \$48.

187-24. Handicapped Parking.

A. Definitions: As used in this article, the following terms shall have the meanings indicated: Handicapped person - means any person who has lost the use of one or more limbs as a consequence of paralysis, amputation, or other permanent disability or who is permanently disabled as to be unable to ambulate without the aid of an assisting device or whose mobility is otherwise limited as certified by a physician with a plenary license to practice medicine and surgery in this state or bordering state. "Handicapped person" shall also mean any person who has temporarily lost the use of one or more limbs, is temporarily unable to ambulate without an assisting device or whose mobility is otherwise temporarily limited, said temporary disabilities as described above having been certified to by a physician of this or a neighboring state licensed to practice medicine and surgery in that state. Other type of temporary disability will serve as grounds for certification by a licensed physician. For the purposes of this article, licensed physician shall include those persons licensed as chiropractors.

Handicapped person identification card means:

- 1. The identification card issued to a handicapped person by the director of the division of motor vehicles in the department of law and public safety, pursuant to N.J.S.A. 39:4-205. "Handicapped person identification card" shall also mean the placard issued by the borough police department to an applicant upon the certification of a physician that the applicant is temporarily disabled in one of the ways described in the definition of "handicapped person" above. Placards issued by the borough police department pursuant to this article shall remain valid for six months from the date of issuance, with only one extension of six months allowed, and shall have listed upon them the date such placard expires.
- 2. The category of handicapped person identification card shall also include handicapped nursing home resident identification cards issued to nursing home owners or operators for use by that person in a vehicle owned or operated by the nursing home and used to transport handicapped nursing home residents.

Handicapped person placard or license plate means the placard or license plate issued to a handicapped person pursuant to N.J.S.A. 39:4-206, indicating that the person has been issued a handicapped person identification card, such placard or license plate to be displayed on the motor vehicle used to transport the handicapped person when the vehicle is parked in parking spaces designed for use by handicapped persons.

Parking lot means any area, inside or outside a public building or upon private property, set aside for the parking of vehicles with or without charge to the owners of these vehicles.

Public building means any building, structure, facility or complex used by the general public or to which the general public is invited, including, but not limited to, theaters, concert halls, auditoriums, museums, schools, libraries, hospitals, recreation facilities, office buildings, factories, business establishments, public eating places, motels and hotels, shopping centers and the like, whether publicly or privately owned, except that this term shall not include private family residences, warehouse storage areas and all buildings containing hazardous occupancies that involve highly combustible, highly flammable or explosive materials.

B. Handicapped parking spaces established.

Parking spaces restricted for use by handicapped persons who have been issued handicapped person identification cards, and display handicapped person placards or license plates, are hereby established in all parking lots within the borough provided in conjunction with or to serve public buildings, the specific locations of which shall be determined upon approval of the sketch plan required by this article.

C. Guidelines for designation of handicapped parking spaces.

- 1. The designated handicapped parking spaces shall be located in an area of the parking lot, which is most accessible and proximate to the public building(s) the lot serves, as approved by the Borough of South Plainfield.
- 2. The signing and pavement marking of handicapped parking spaces shall conform to the specifications as prescribed by the New Jersey Department of Transportation in the latest revision of the Manual on Uniform Traffic Control Devices for Streets and Highways. All signs indicating the existence of handicapped parking spaces shall, state the penalties imposed for violations of this article.
- 3. Each handicapped parking space shall be a minimum of 12 feet in width or as required by the American Disabilities Act or residential site improvement standards to permit handicapped persons to get in and out of either side of a motor vehicle onto a level, paved surface suitable for wheeling and walking.
- 4. Where possible, such spaces shall be located so that handicapped persons are not compelled to wheel or walk behind parked cars.

D. Compliance sketch plan ordinance.

The owners of all premises required to provide handicapped parking spaces as specified herein shall submit a sketch plan indicating the present or proposed location of such spaces to the Borough of South Plainfield. The sketch plan shall require approval by the code

department and planning and engineering departments and shall be retained and kept on file in the planning and engineering department. The sketch plan must be approved prior to the installation of any handicapped parking spaces. In all cases, except as otherwise determined by the planning or zoning board, once the sketch plan has been approved, the owner shall have 60 days from the date of approval to install and mark new handicapped spaces or correct deficiencies in existing spaces. Any owner failing to submit a sketch plan as required or to provide properly designated and marked handicapped parking stalls within the time periods prescribed in this article shall be subject to penalties in accordance with this article.

E. Maintenance of markings.

All signing, pavement, markings, depressed curbing and/or ramps shall be maintained in good and proper condition, including but not limited to the condition that required markings and signs should remain distinctly visible at all times. Any owner of premises required to provide handicapped parking spaces who shall fail to maintain such spaces in proper condition shall be subject to penalties in accordance with this article.

F. Handicapped parking spaces restricted.

- 1. Except when necessary to avoid conflict with other traffic or in compliance with the directions of a traffic or police officer or traffic sign or signal, no operator of a vehicle shall stand or park the vehicle in any space appropriately designated for use by the physically handicapped unless the vehicle is authorized by law to park therein.
- 2. Where a passenger or driver of a motor vehicle is authorized by his possession of handicapped person identification card to park in a handicapped parking space, the identification card or placard shall be placed on the top of the dashboard near the steering wheel so as to be visible through the front windshield of the car, and failure to place this identification card as described above when otherwise properly parking in a handicapped parking space will constitute a violation of this article subject to the penalties within this article.

G. Enforcement.

This article shall be enforced by the Police Department of the Borough of South Plainfield.

H. Violations and Penalties.

- Any person parking a motor vehicle in a parking space appropriately designated as
 restricted for use by handicapped persons without a special vehicle identification card
 issued by the division of motor vehicles pursuant to N.J.S.A. 39:4-204 et seq. and 39:4197.5, as amended, shall be subject to a fine as set forth in N.J.S.A. 39:4-197(3)c, as
 amended.
- 2. No penalty shall be imposed for the parking overtime of any vehicle which has displayed thereon a placard or wheelchair symbol license plate unless such vehicle shall have been parked in one location for more than 24 hours, as long as the driver or a passenger of said car at the time of the overtime parking has a valid placard or special license plate issued to him or her.

3. Any person who violates this section by failing to designate or maintain handicapped parking spaces as required hereunder or otherwise fails to comply with any section of this article shall be liable for a penalty of not more than \$1,250.00 or imprisonment for not more than 90 days or both. Each and every day of noncompliance shall be considered a separate violation.

Article III. Through Streets.

187-25. Through Streets Established.

A. Pursuant to the provisions of N.J.S.A. 39:4-140, the streets or parts of streets described are hereby designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the through street except where yield signs are provided for in the designation.

Article XII. Off Road Vehicles.

187-34. Regulating of off road vehicles.

- 1. The purpose of this Ordinance shall be to set standards for the operation of motor-driven offroad vehicles within the Borough of South Plainfield to minimize the impact of operation of such vehicles on residents of the Borough, the public at large, the environment, and ensure minimum standards of safety.
- 2. As used in this Chapter, the following terms shall have the meanings indicated:
 - a. Motor Vehicle Any vehicle that is propelled by other than human or animal power;
 - b. Off-Road Vehicle Motor vehicles which are capable of human transport and designed or used for the purpose of recreation off of the public right-of-way, including, but not limited to, all-terrain vehicles, trail/dirt bikes; mini bikes; go-carts; and snow mobiles. This Chapter shall not apply to lawn mowers, tractors or farm, lawn, garden or similar equipment for residential use, or business or agricultural/farming activities when used for purposes for which each was designed; and
 - c. Public Property Lands owned, leased or under the jurisdiction of the Borough of South Plainfield or the Borough of South Plainfield Board of Education.
- 3. It shall be unlawful to operate any off-road vehicle under the following circumstances:
 - a. On the property of another person or party, unless the operator of the off-road vehicle has written permission of the owner or legal occupant of said property to operate the off-road vehicle thereon, or said property owner is present. Said written permission must be exhibited to police officers upon request;
 - b. On any public street, sidewalk or bike path within the Borough;
 - c. On public property unless written permission for operation of the off-road vehicle on said property has been specifically given by the applicable public authority; or
 - d. Within 450 feet of an occupied dwelling, other than the dwelling of the operator, or on other property where permission has been granted in a manner creating: Any harsh, objectionable or unreasonable noise so as to disturb or interfere with the peace and quiet of other persons or which produces noise in violation of the Code of the Borough of South Plainfield; or The presence in the outdoor atmosphere of airborne dust, dirt or debris, or in an unsafe manner creating a physical hazard, beyond the property line on which the off-road vehicle operates such that it interferes with the enjoyment of life or property of the adjoining property occupant.
- 4. It shall be unlawful for the owner or person having control or custody of an off-road vehicle to allow or enable a minor (under age 18) to operate said off-road vehicle in a manner violating any section of this Chapter. When a minor operates an off-road vehicle in violation

of this Chapter, it shall be a rebuttable presumption that the parent or guardian of said minor enabled the off-road vehicle to be so operated.

5. Exemptions:

- a. Off-road vehicles used in or related to agricultural/farming activities, gardening, yard work and for snow removal; or
- b. Loading and unloading of off-road vehicles during transit to and from public roadways.
- 6. Reports of the prohibited acts from two or more persons who are in general agreement as to the times and duration of the prohibited acts and who reside in separate residences, including apartments and condominiums, located within 200 feet of a property line (boundary) from the property on which the source of prohibited acts occur shall create a rebuttable presumption of a violation of this Ordinance. However, nothing in this Chapter shall preclude a single individual from registering a complaint for any violation of this Ordinance.
- 7. It shall be unlawful for any off-road vehicle to be operated within the Borough of South Plainfield which does not conform to current Federal or State standards for the type of off-road vehicle in question. If no such standard exists, then recognized standards by bodies or industry trade association standards shall be used, if available.
- 8. It shall be unlawful for any off-road vehicle to be operated without a muffler. For two-cycle engines, a United States Forest Service approved muffler/spark arrester combination is required.
- 9. The following shall consist of violations and penalties;
 - a. Violation of any section of this Chapter shall constitute a separate and distinct offense independent of the violation of any other section or any order issued pursuant to this Ordinance. Each day of violation shall constitute an additional, separate and distinct offense;
 - b. For a first violation of any section of this Chapter, the following penalty may be imposed:
 - 1. In a case where a minor is involved, a verbal first warning and a copy of this Ordinance may be provided to both the minor and the parent or legal guardian in lieu of a summons at the discretion of the police officer. If a warning is issued, and if within 90 days, the off-road vehicle is in question is again operated in a manner which is found to be in violation of this Ordinance (not necessarily the same offense), the parent or guardian of the operator shall be cited for violation of this Chapter, and subject to the penalties herein;
 - 2. In cases where a minor is not involved, for a first offense, the operator shall be subject to a fine of not more than \$1,000.00; and
 - 3. For a second or more violation of this Chapter, the violator shall be subject to a fine of \$100.00 to \$2,000.00, community service of 90 days, or both, within the discretion of the Municipal Cou

Article XV. Traffic Regulations on Private Property.

187-37. Enforcement of traffic regulations on private property. Where a request in accordance with N.J.S.A. 39:5A-1 has been made by a property owner and approved by the Borough engineer, all of the provisions of Subtitle 1, Title 39, of the Revised Statutes (N.J.S.A. 39:1-1 et seq.) shall apply, together with any approved regulations specifically appropriate to the property. All properties for which such a request has been approved, with or without regulations specifically appropriate to the property, shall be set forth as listed below:

A. General.

1. Enforcement by the Borough shall commence upon approval of the request by the Borough engineer and adoption of an appropriate ordinance by the Borough. The approved regulations as to any such property shall be set forth as listed below, and shall be enforced in accordance with subsection A. of this section.

2. General.

- a. In accordance with the provisions of Subtitle 1, Title 39, of the Revised Statutes (N.J.S.A. 39:1-1 et seq.) shall be enforced by the Borough of South Plainfield Police Department on the properties designated in this section, together with the specific regulations set forth as to each property.
- b. All vehicles shall park in designated areas and between the lines provided.
- 3. Reserved parking. All vehicles that are granted specialty parking in this subsection such as police vehicles, ambulances, teachers, etc., must be properly identified and the reserved parking spaces must be shown on the enclosed site plan.
- 4. Tow-away zones. Any vehicle parked or standing so as to obstruct or impede a normal flow of traffic, block entrances or exit ways, loading zones, oil fills, any grassy area, pedestrian walkways or present in any way a safety or traffic hazard may be removed by towing the vehicle at the owner's or operator's expense.

The owner shall be responsible for the repair and restoration or replacement of same.
 - 2. Penalty. Unless another penalty is expressly provided by statute, every person convicted of a violation of this section or any supplement thereto shall be liable to a penalty as prescribed by 187-2 of this ordinance.
