#### **COUNCIL REPORTS:**

Borough Attorney Paul Rizzo, Esq. - had no report for this evening.

Administrator Cullen – said he would like to acknowledge all the Boy Scouts in attendance tonight and give everyone a copy of the before and after pictures of what William Walsh this past Summer did his Eagle Scout Project on; the painting of the interior of our community hall. It was a great project for him that took a couple of weeks to complete. It was a great job that was done and we really appreciate it. Council President Rusnak agreed.

<u>Engineer Miller</u> – briefed the Council on the status of the road improvement projects. T&M has resubmitted work for the DEP pertaining to the Hollywood Avenue Truck By-Pass Route a while back concerning an alternate route. We have followed up with them to obtain a response and they said we should be receiving one soon so we will know better where we stand and how to move forward. On another note, we are looking to close out the Sampton Avenue Road Improvement Project. The core samples have been done. There are some minor items that the Contractor needs to take care of.

<u>Clerk Antonides</u> – had no report for this evening.

Councilman Diana – noted that on a number of occasions since November residents on the south side of town have brought up concerns with the truck noise. Mr. Diana said he knows Chief Parker is doing his job as well as all the other guys in the Police Department. Mr. Diana said he wonders if the problem is more of a question of signage and if there is something that we can do to let the truck drivers know they are not supposed to go past a certain point. Mr. Diana said he knows we have an electronic sign that perhaps that can be utilized and would like to have that looked into. On another note, Councilman Diana said he was aware that the Fire Department had its ball this past weekend and unfortunately he was not able to attend it and hopes to be able to attend it next year.

<u>Councilman Barletta</u> – advised that he was able to attend the Firemen's dinner this past Saturday evening and it was so nice to see the firemen out with their wives and/or girlfriends enjoying themselves because they work so hard throughout the year and spend so much time away from their families. It was so nice to see everyone enjoy themselves and have a good time. Councilman Barletta thanked them all again for all that they do.

Councilman Bengivenga – concurred with what Councilman Barletta said. It was a pleasure and honor to be there at the firemen's dinner. Being the Fire Commissioner the past few years it has been a real pleasure to work with these men as well as all of our emergency service personnel. We are looking forward to a lot of things this year. We have a new fire truck coming in the Spring. Councilman Bengivenga said in regard to Councilman Diana's remarks this evening regarding signage, he will be happy to bring the matter up once again in the Traffic Safety Committee. Mr. Bengivenga said he believe we have some five signs already posted leading up from 287. Mayor Anesh interjected that it has been brought up that the real area of concern is the lack of proper GPS updates.

Mayor Anesh said that he believes there is a decent amount of signs already out there, not saying that more may be a bad idea, but just suspects that proper GPS updating is a key factor. Mayor Anesh suggested that someone reach out to the major GPS companies out there who install such updates.

<u>Councilman McConville</u> – reported that he too attended the firemen's dinner on Saturday night and noted that there were 3 current and/or former Mayor's in attendance which was a pleasure to see. Councilman McConville thanked the Governing Body this evening for their support of the DPW. The generator will truly be an asset to the DPW and help them out tremendously during these power outages. Other than that, Councilman McConville reported progress.

Councilman White – congratulated the South Plainfield wrestling team on the first time that they won this particular tournament, which marks a mile stone for them. Councilman White reminded everyone that Aristacare will be having a program focusing on Alzheimer's which will be held right at Artistacare at 9:00 a.m. on January 22<sup>nd</sup>. It is open to the public to attend. Councilman White concluded by advising that it has been brought to his attention that NJ American Water is doing some maintenance between now and some time in February. For those who have NJ American Water they may encounter a brief chlorine type of smell, but it will be only temporary.

Council President Rusnak – advised that he recently saw some correspondence authored by the Mayor to our Board of Freeholders pertaining to Open Space Grant Funding and noted that over the past three years South Plainfield residents have paid some \$3,221,153.75 in open space funds to Middlesex County and to his knowledge, over these past three years we have received nothing back in return. That is a lot of money for our residents to be paying out to not see something in return. I also saw attached to the Mayor's correspondence to the Board of Freeholders at least eleven letters to the County in this regard and yet for them to not respond back to us is very disturbing. It is a matter we definitely need to look into. Council President Rusnak said he would like to see the Mayor's letter posted on our website for all our residents to see. On another note, Council President Rusnak said a little over a month ago this Governing Body passed a resolution seeking that the County and Schools pay their fair share of the tax appeal refunds. We had sent a copy of our resolution over to Edison seeking their support, and Edison has responded by passing the same resolution. Also, in yesterday's Star Ledger there was a list posted of all the property taxes by County throughout the State. Out of 25 towns in Middlesex County, South Plainfield has the 5<sup>th</sup> best tax rate in the County. However, 18 municipalities in Middlesex County have a better County tax rate than we do. Between this and our residents not seeing any benefit from paying out so much in Open Space Funds to the County, this is something we really will need to look into this year to see if there is anything we can do about it.

Mayor Anesh – thanked Council President Rusnak for his report this evening. Mayor Anesh pointed out some variables as it relates to the Statewide average for taxes. On another note, Mayor Anesh advised that during 2012 we have received \$5,700 in wedding fees in which \$2,000 of that is State mandated to go toward the New Jersey Domestic Violence Program. Typically the balance of that goes toward a local South Plainfield charity. We are in the process of reaching out to all the couples that were married and aside from wishing them well, are asking for their input as to what charity we should donate the balance to. To conclude, Mayor Anesh discussed the Hollywood Avenue Extension Project saying that when the Lt. Governor was here recently she asked how we were doing with the project and said that the State is well aware of it. We will continue to forge on with it and hope to see results in the near future.

Mayor Anesh opened the floor for public comment. With no comments from the public, Mayor Anesh closed the floor. At this time, 7:41 p.m., Mayor Anesh advised that the Council will be going into Executive Session and everyone is welcome to stay for their return back into public session.

Without further comment, Mayor Anesh called for a motion to adjourn. Councilman Barletta made a motion to adjourn at 8:09 p.m., seconded by Councilman McConville and unanimously carried. The meeting was adjourned.
