<u>ORDINANCE – FIRST READING BY TITLE</u> – was read by Clerk Antonides by title. The public hearing was set for August 12, 2013 at approximately 7:00 p.m.:

BOND ORDINANCE 1991

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$577,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$273,250 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of South Plainfield, in the County of Middlesex, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$577,000, and further including the aggregate sum of \$23,750 as the several down payments for the improvements or purposes required by the Local Bond Law and further including a grant in the amount of \$280,000 from the State of New Jersey Department of Transportation for improvements to Montrose Avenue. No down payment is required pursuant to N.J.S.A. 40A:2-11(c) for the cost of the improvements to Montrose Avenue since this purpose is being partially funded by the State Grant. The amount of the down payment appropriated is at least 5% of the costs of the improvements or purposes which are not

funded by the State Grant (\$297,000). The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments and the State Grant, negotiable bonds are hereby authorized to be issued in the principal amount of \$273,250 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

| d) Acquisition of easements on Stelton Road, including all related costs and expenditures incidental thereto. TOTAL: | \$ <u>95,000</u> \$ <u>577,000</u> | \$ <u>90,250</u> \$273,250 | 40 years |

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvements or purposes described in Section 3(a) of this bond ordinance are not current expenses. They are all improvements or purposes that the Borough may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

- (b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 19.41 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$273,250, and the obligations authorized herein will be within all debt limitations prescribed by that Law.
- (d) An aggregate amount not exceeding \$74,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements.
- Section 7. The Borough hereby declares the intent of the Borough to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes or improvements described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.
- Section 8. Any grant moneys received for the purposes or improvements described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or, if other than the State Grant referred to in Section 1 hereof, to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.
- Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the ARule@) for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the

event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

WHEREAS, failure to comply with the promulgation's of the Local Finance Board of the State of New Jersey may subject the members of the local Governing Body to the penalty provisions of R.S. 52-27BB-52 to wit: R.S. 52:27BB-52 – "A local officer or member of a local Governing Body who, after a date fixed for compliance, fails or refuses to obey an order of the Director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office".

RESOLUTION 2013-235

RESOLUTION AUTHORIZING SETTLEMENT OF 2009, 2010, 2011, 2012 AND 2013 TAX APPEALS FILED BY VNB REALTY, INC., FOR THE PROPERTY KNOWN AS 100 DURHAM AVENUEAND IDENTIFIED AS BLOCK 541, LOT 6.01, ON THE BOROUGH OF SOUTH PLAINFIELD TAX ASSESSMENT MAPS

WHEREAS, VNB Realty, Inc. (hereinafter referred to as "Taxpayer") is the owner of the property known as 100 Durham Avenue and identified as Block 541, Lot 6.01, on the Borough of South Plainfield's Tax Assessment Maps ("Property"); and

WHEREAS, the assessed value of the Property was set at \$600,000 for 2009, 2010, 2011, 2012 and 2013; and

WHEREAS, Taxpayer filed appeals of the 2009, 2010, 2011 and 2012 tax assessments in the Tax Court of the State of New Jersey under docket numbers 013709-2009, 014232-2010, 010626-2011 and 011298-2012; and

WHEREAS, Taxpayer filed an appeal of the 2013 tax assessment with the Middlesex County Board of Taxation; and

WHEREAS, a proposed settlement of the aforesaid tax appeals was negotiated between Taxpayer and the Borough Tax Assessor and Borough Tax Attorney as set forth in the Stipulation of Settlement annexed hereto; and

WHEREAS, the Borough Appraiser, Russ Sterling, MAI, opined that the Borough was not able to defend the assessments for the 2011, 2012 and 2013 tax years under appeal and recommended that the settlement be approved and therefore, this proposed settlement is reasonable and reflects the correct market values for the Property which was over assessed for Tax Years 2011, 2012 and 2013; and

WHEREAS, pursuant to the proposed Stipulation of Settlement annexed hereto, the aforesaid tax appeals are to be resolved as follows:

- The 2009 tax appeal shall be withdrawn by Taxpayer;
- The 2010 tax appeal shall be withdrawn by Taxpayer;
- The 2011 original assessment in the amount of \$600,000 shall be reduced to \$550,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax credit for 2011;
- The 2012 original assessment in the amount of \$600,000 shall be reduced to \$550,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax credit for 2012;
- The 2013 original assessment in the amount of \$600,000 shall be reduced to \$525,000 and the Borough of South Plainfield shall provide Taxpayer with a corresponding tax credit for 2013;

- The parties agree that the provisions of <u>N.J.S.A.</u> 54:51A-8 (Freeze Act) shall apply to the assessment for tax year 2014;
- Taxpayer has agreed to waive statutory interest;
- Taxpayer has agreed that any adjustments to taxes as a result of the settlement shall be credited toward future taxes in lieu of refunds, which credits shall be applied to the next quarterly payment due after entry of Judgment.

WHEREAS, the Borough of South Plainfield Tax Assessor agrees that it is in the best interests of the Borough of South Plainfield to resolve the aforesaid tax appeals pursuant to the terms and conditions set forth above and in the Stipulation of Settlement annexed hereto based on market conditions as well as the uncertainty and costs associated with continued litigation; and

WHEREAS, the aforesaid settlement is based on the specific and identifiable facts and circumstances pertaining to the Property and has no general application to other properties within the Borough of South Plainfield; and

WHEREAS, the Mayor and Borough Council of South Plainfield having reviewed and considered the pending tax appeals and the proposed settlement thereof agree and confirm it is in the best interests of the Borough of South Plainfield to resolve the tax appeals as set forth herein and in the Stipulation of Settlement attached hereto; and

WHEREAS, the Mayor and Borough Council make this settlement with the Taxpayer without prejudice to its dealing with any other South Plainfield taxpayer's request for tax assessment reduction; and

WHEREAS, the Mayor and Borough Council leave the allocation between land and improvements of the aforesaid tax assessment reduction to the Borough Tax Assessor's discretion with the direction that same be set so as to be most beneficial to the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of South Plainfield, County of Middlesex, State of New Jersey, as follows:

- 1. The Borough Tax Assessor is hereby directed to establish the allocation between land and improvements of a \$550,000 total tax assessment reduction for the 2011 and 2012 tax years for Block 541, Lot 6.01 which is most beneficial to the Borough and advise the Borough Attorney of that allocation.

RESOLUTION 2013-253

AUTHORIZING THE EXTENSION OF TAX PAYMENT GRACE PERIOD

WHEREAS, municipalities are required to charge interest on delinquent tax payments under the provisions of R.S. 54:4-66 and R.S. 54:4-67; and

WHEREAS, municipalities are also allowed to grant a grace period during which time interest will not be charged on delinquent tax payments; and

WHEREAS, the Taxpayers of the Borough of South Plainfield are entitled to a grace period wherein interest will not be charged; and

WHEREAS, tax bills are expected to be mailed by July 26, 2013;

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE BOROUGH OF SOUTH PLAINFIELD, that interest at the rate of ten-millionth of one percent (0.0000001%) per annum shall be charged on the tax bills nominally due on August 1, 2013 provided that the payment therefore is actually received by the Tax Collector on or before August 20, 2013; and

BE IT FURTHER RESOLVED, that any quarterly property tax installment due for the third quarter of Calendar Year 2013 for which payment has not been received by August 20, 2013 shall be charged interest from August 1, 2013 to the date that the payment is actually received by the Tax Collector, to be calculated at the rate of

eight percent (8%) per annum on the first \$1,500.00 of the delinquency, and at eighteen percent (18%) per annum on any and all delinquent amounts in excess of \$1,500.00; and

BE IT FURTHER RESOLVED, that beginning with the fourth quarterly installment of Calendar Year 2013 due and payable on November 1, 2013, and continuing for all tax quarters thereafter, interest shall be charged on delinquent payments at the rates of eight percent (8%) per annum on the first \$1,500.00 of the delinquency, and at the rate of eighteen percent (18%) per annum on any and all delinquent amounts in excess of \$1,500.00, to be calculated from the date that the payment was originally due until the date that the payment is actually received by the Tax Collector.

COUNCIL REPORTS:

Borough Attorney Paul Rizzo, Esq. – had no report for this evening.

Administrator Cullen – advised that earlier this evening the DPW got together to discuss potential road projects to apply for state grant funding. During this meeting it was decided that Franklin Avenue is the best road to submit a request for said grant funding. The council would need to advise Mr. Miller if they wish to proceed in this regard. The Council briefly discussed different options of roads in need of paving and concluded based on Mr. Miller's recommendation that Franklin Avenue may be the most advantages of roads to be chosen for a grant award due to main connecting roads. Mr. Miller said he will proceed to put the application together for submittal.

<u>Engineer Miller</u> – said that regarding the road program, the contractor will be out there starting this week to begin with the concrete work. The DOT grant will be worked on in the coming days. We will look at Franklin Avenue for this grant. They have to be filed by September. Mayor Anesh asked Mr. Miller about the status of the bus route permit. Mr. Miller said the plans were resubmitted last Friday. We wait to hear back from the state. We are also about to submit plans to the state pertaining to the library edition.

Clerk Antonides – had no report for this evening.

<u>Councilman Diana</u> – Presented the Council with some photos of the Highland Woods Preserve advising that the Environmental Commission just put up some deer fencing with grant funding. It was a nice job that was done. Councilman Diana expressed his concerns for the seniors saying how dangerous the high temperatures can be for them.

Councilman Barletta – advised that the Knights of Columbus will have their Food Drive on July 19th from 8:00 am to 5:00 pm. The Christmas in July event is fast upon us of which event is to encourage residents to support their local businesses. Councilman Barletta also advised that at last week's Planning Board meeting, Restaurant Depot was approved to move their facility to New Durham Avenue as they have outgrown their current location. We are pleased to be able to keep them in South Plainfield. Some discussion was had regarding traffic flow on New Durham Avenue, but it was mentioned that this is being looked into with a possibility of installing another traffic light.

<u>Councilman Bengivenga</u> – reminded everyone that this Sunday is the Rescue Squad's Car Show fund raiser from 11 am to 3pm.

Councilman McConville - reported progress.

<u>Councilman White</u> – announced that the Public Celebrations will be accepting nominations for this year's Grand Marshal for the Labor Day Parade. Information is posted on the Borough's website.

<u>Council President Rusnak</u> – explained that resolution #13-253 was put on the agenda this evening because the tax bills will be going out a little bit late. This resolution will extend the grace period from August 10th to August 20th. Residents will probably start to receive their tax bills toward the end of July.

<u>Mayor Anesh</u> – brought up a potential need for a cooling center in South Plainfield for the coming week in particular with very high temperatures in the forecast. The Senior Center would be a site for such a cooling center. Mr. Cullen said that is correct. We recently had the main compressor unit repaired at the Senior Center due to vandalism. Mr. Cullen said the cooling center didn't receive any use today, but as it gets hotter during the week, maybe it will be put to use by some. Mayor Anesh went on to suggest getting the word out to residents that the cooling center is available to anyone in need. Perhaps a Nixel message could be sent. Concerns were expressed regarding a high turnout in need of this cooling center. It was then suggested that the Pal Building could be used, perhaps some schools, etc. It was briefly noted that the pool hours have been extended.

Mayor Anesh also advised that he attended the benefit concert for Brittney which was a great show put on by former students. The music was wonderful. Mayor Anesh also advised that he enjoyed the recent Summer Drama breakfast.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

Mrs. Nancy Grennier gave the Council a progress report on the forthcoming Christmas in July event. There are about 15 vendors so far. There will be a band and a DJ. Summer Drama kids will be present as well as local Scouts. A dunk tank will be there and we are seeking volunteers.

Debbie Boyle of Van Fleet thanked the Mayor Anesh for speaking at the concert for Brittney last evening. About \$5,000.00 was raised with about 250 in attendance.

With no further comments from the public, Mayor Anesh closed the floor.

At 7:45 p.m. Mayor Anesh called for an adjournment from the public portion of the meeting to go into Executive Session.

ADJOURNMENT

Without further comment and no more action necessary for this evening, Mayor Anesh called for a motion to adjourn. Council President Rusnak made a motion to adjourn at 8:05 p.m., seconded by Councilman White and unanimously carried. The meeting was adjourned.
