**ORDINANCE – SECOND READING BY TITLE** was read by Clerk Antonides for Ordinances 2065. Mayor Anesh opened the floor for public hearing. With no comments from the public, Mayor Anesh closed the floor.

## ORDINANCE NO.2065 AN ORDINANCE ESTABLISHING PROCEDURE FOR TAKING <u>ACTION REGARDING UNSAFE PROPERTIES WITHIN THE BOROUGH.</u>

WHEREAS, State statute, N.J.S.A. 40:48-2.5, provides that a municipality is authorized to adopt an ordinance relating to buildings within the municipality which are unfit for human habitation or occupancy or use; and

**WHEREAS,** such ordinance is necessary for the Borough to address any issue with buildings where in the Construction Official has determined that a building is unfit for human habitation or occupancy or use; and

WHEREAS, the Governing Body of the Borough of South Plainfield has determined that such an ordinance is necessary and appropriate;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that upon the adoption of a resolution by the Governing Body finding that building conditions are such that a building is so old, dilapidated, or has become so out of repair to be dangerous, unsafe, unsanitary or otherwise unfit for human habitation, or occupancy, or use, is inimical to the welfare, and dangerous and injurious to the health and safety of people, and that a public necessity exists for the repair, closing or demolition of such building or buildings, or part thereof, the Construction Official of the Borough is designated or appointed to exercise the powers proscribed hereinafter.

1. Whenever a petition is filed with the Construction Official by a public authority or by at least five residents of the municipality charging that any building is unfit for human habitation or occupancy or use, or whenever it appears to the Construction Official (on his own motion) that any building is unfit for human habitation or occupancy or use, the Construction Official shall, if his preliminary investigation discloses a basis for such charges, issue and cause to be served upon the owner of and parties in interest in such building a complaint stating the charges in that respect, and containing a notice that a hearing will be held before the Construction Official (or his designated agent) at a place therein fixed not less than 7 days nor more than 30 days after the serving of said complaint; that the owner and parties in interest shall be given the right to file an answer to the complaint and to appear in person, or otherwise, and give testimony at the place and time fixed in the complaint; and that the rules of evidence prevailing in the courts shall not be controlling in hearings before the Construction Official.

2. That if, after such notice and hearing, the Construction Official determines that the building under consideration is unfit for human habitation or occupancy or use, he shall state in writing his findings of fact in support of such determination and shall issue and cause to be served upon the owner thereof and parties in interest an order:

a. Requiring the repair, alteration or improvement of the said building to be made by the owner, within a reasonable time, which time shall be set forth in the order or at the option of the owner to vacate or have said building vacated and closed within the time set forth in the order; and

b. If the building is in such a condition as to make it dangerous to the health and safety of persons on or near the premises, and the owner fails to repair, alter or improve said building within the time specified in the order, then the owner shall be required to remove or demolish said building with a reasonable time as specified in the said order of removal.

3. That, if the owner fails to comply with an order to repair, alter or improve or, at the option of the owner, to vacate and close the building, the Construction Official may cause such building to be repaired, altered or improved, or to be vacated and closed; and the Construction Official may cause to be posted on the main entrance of any building so closed a placard with the following words: "This building is unfit for human habitation or occupancy or use; the use or occupation of this building is prohibited and unlawful."

4. That, if the owner fails to comply with an order to remove or demolish the building, the Construction Official may cause such building to be removed or demolished or may contract for the removal or demolition thereof after advertisement for, and receipt of, bids therefor.

5. That the amount of:

a. The cost of the filing of legal papers, expert witnesses' fees, search fees and advertising charges incurred in the course of any proceeding taken under this act determined in favor of the municipality, and

b. The cost of such repairs, alterations or improvements, or vacating and closing, or removal or demolition if any, or the amount of the balance thereof remaining after deduction of the sum, if any, realized from the sale of materials derived from such building or from any contract for removal or demolition thereof, shall be a

municipal lien against the real property upon which such cost was incurred. If the building is removed or demolished by the Construction Official, he shall sell the materials of such building. There shall be credited against the cost of the removal or demolition thereof, including the clearance and, if necessary, leveling of the site, the proceeds of any sale of such materials or any sum derived from any contract for the removal or demolition of the building. If there are no such credits or if the sum total of such costs exceed the total of such credits, a detailed statement of the aforesaid costs and the amount so due shall be filed with the Borough Tax Assessor or other custodian of the records of tax liens, and a copy thereof shall be forthwith forwarded to the owner by registered mail. If the total of the credits exceed such costs, the balance remaining shall be deposited in the Superior Court by the Construction Official, shall be secured in such manner as may be directed by such court, and shall be disbursed according to the order or judgment of the court to the persons found to be entitled thereto by final order or judgment of such court. Any owner or party in interest may, within 30 days from the date of the filing of the lien certificate, proceed in a summary manner in the Superior Court to contest the reasonableness of the amount or the accuracy of the costs set forth in the municipal lien certificate.

If an actual and immediate danger to life is posed by the threatened collapse of any fire-damaged or other structurally unsafe building, the Construction Official may, after taking such measures as may be necessary to make such building temporarily safe, seek a judgment in summary proceedings for the demolition thereof.

This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.

# ORDINANCE NO.2067 AN ORDINANCE AMENDING ARTICLE XI OF THE BOROUGH ZONING ORDINANCE.

**WHEREAS,** the courts have declared that the power to allow expansion of non-conforming uses resides exclusively with boards of adjustment, and any ordinance purportedly permitting such an expansion is improper;

**NOW, THEREFORE, BE IT ORDAINED** by the Governing Body of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Section 1103 of Article XI, Non-Conforming Uses, shall be and is hereby deleted.

**WHEREAS**, the Borough of South Plainfield has participated as a member of the Middlesex County Municipal Joint Insurance Fund (hereafter the "Fund") existing pursuant to Chapter 372, Laws of 1983 (40A:10-36 et. seq.) and is desirous of continuing said membership for a term expiring on December 31, 2019;and

**WHEREAS**, the governing body of the Borough of South Plainfield has determined that continued membership in the Fund is in the best interest of the municipality; and

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of South Plainfield County of Middlesex the following:

**SECTION 1.** The borough hereby agrees to continue as a member of the Fund for a period commencing January 1, 2017, and terminating on December 31, 2019 for the purpose of securing the following types of insurance coverage:

- a) Workers Compensation and Employer's Liability
- b) Property Damage (including Buildings and contents, automobile physical damage, contractors equipment, boiler and machinery and public employee blanket bonds)
- c) Motor Vehicle and Equipment Liability.
- d) General Liability including Public Officials and Police Professionals

After the expiration of the three (3) year period of membership, participation may be cancelled or extended in accordance with the By-Laws of the Fund.

**SECTION 2.** For the purposes of contribution of sums into the Fund to be designated for administrative costs and claims, the Borough of South Plainfield hereby agrees to obtain the types of coverage from the Fund as set forth in Section 1 of this Resolution and Indemnity and Trust Agreement to be signed by it.

**SECTION 3.** The By-Laws of the Middlesex County Municipal Joint Insurance Fund have been adopted and accepted.

**BE IT FURTHER RESOLVED** that the Mayor and Municipal Clerk are hereby authorized and directed to execute the Indemnity and Trust Agreement and such other documents signifying membership in the Fund as are required by the Fund's bylaws and to deliver same to the Executive Director of the Fund

## **COUNCIL REPORTS:**

Borough Attorney Rizzo Esq. - reported progress

<u>Administrator Cullen</u> – advised that we received the Moody's report giving us a AA2 rating. The state of New Jersey had their tenth downgrade today whereas we are moving in the opposite direction. PARSA has advised that their rates will remain the same so there will be no increases in that regard for the forthcoming budget. We have not had a rate increase with them since 2012. On another note, Mr. Cullen reported that JFK will be merging with Hackensack Meridian Health which should be an enhancement of services.

<u>Engineer Miller</u> – reported that the Franklin Avenue road improvement project is in progress and is hopeful that it will be completed within the next two weeks.

<u>Clerk Antonides</u> – reported progress.

<u>Councilman Elect Dean</u> – no report at this time.

<u>Councilman Elect Vesce</u> – thanked the Mayor and Council for including he and Councilman Elect Dean at the table this evening and looks forward to working with them.

Councilman Wolak – reported progress.

<u>Councilman White</u> – thanked the Council for their support this evening in adopting Ordinance 2065. It will give some much needed authority to our Construction Official.

Councilman Rusnak - reported progress.

<u>Councilman Richkus</u> - echoed Councilman White's sentiments regarding Ordinance 2065. Councilman Richkus asked Mr. Miller what the status is of the GPS unites in the DPW vehicles. Mr. Miller said they are all ready for use this coming winter.

<u>Councilwoman Faustini</u> – thanked everyone for their help in getting acclimated and answering her many questions and also went on to congratulate the councilmen elect.

<u>Council President Bengivenga</u> – wished everyone a happy and safe Thanksgiving and congratulated Councilmen Elect Dean and Vesce saying he looks forward to working with them next year.

<u>Mayor Anesh</u> – reported progress and then called the South Plainfield Tiger Tech Robotics team forward who gave a briefing on their 2016-2017 project saying that last season they were extremely successful and they hope to bring the team back to St. Louis again this year. The Mayor and Council congratulated the team and wished them much success this year.

## **COMMENTS FROM THE PUBLIC:**

Mayor Anesh opened the floor for public comment.

Suzanne Lepore, Bullard Place, said that she is sorry to see Councilwoman Faustini leave the Cultural Arts Commission but wishes her well. There will be a library book presentation on December 4<sup>th</sup> at 2:00 p.m. at the library and everyone is welcome to attend.

Debbie Boyle of Van Fleet said she wanted to clear the air about some vicious rumor about the Boyle Memorial Foundation and clarified that they are a 501C organization. On another note, Mrs. Boyle advised that the Taste of South Plainfield has been postponed and will likely be held in February instead

Darleen Cullen, 1457 Fox Place, said that Councilwoman Faustini will be missed on the library board.

Barbara Rhodes of Eganey Street explained that her daughter would on her own like to administer a Field of Honor or a Healing Field in South Plainfield as a fund raiser but does need help; it is a nine month project. Ms. Rhodes advised that she has met with Public Celebrations in September who would partner. Ms. Rhodes said it is a licensing agreement and everything is copy righted and trademarked. Ms. Rhodes already spent \$800.00 for the licensing agreement. 150 flags are being ordered and are \$17.00 each plus \$5.00 freight in 3 increments of \$850.00 each plus freight. Ms. Rhodes said we do need the help of the Public Celebrations Committee, but we feel as though we are being "blocked" with every step of the way. A letter was created and ready to send, but Ms. Rhodes said we couldn't send it because the attorney needed to review it first. Ms. Rhodes said she doesn't understand why we have to do this when it is her project and not the Borough's and that the Public Celebrations is just a partner. Mayor Anesh said this is really unique to anything that the Borough has done. We do need to run certain things through our attorney, that is the right thing to do. Ms. Rhodes said the attorney takes two months. Mr. Rizzo said not him, that is not true. Ms. Rhodes clarified that it's the process that takes too long. Mayor Anesh said that clarification is needed. Is this your event or is this also a Borough event. Ms. Rhodes said it's her event but wants the Borough to help her. Ms. Rhodes said come December 15<sup>th</sup> I want to pay the \$850.00 but wants to be able to pay herself the \$850.00 back - but doesn't want to take it from the Borough but instead to go to the businesses and get the money from them. Mr. Rizzo said that he would like to see the language as to how this is all being represented. Mr. Cullen interjected by asking who is putting out the money. Ms. Rhodes said from business sponsorships. Mr. Cullen said that it sounds like she is doing it all on her own and really the Borough is not involved. Ms. Boyle said that in fact Ms. Rhodes is looking to put the money in the Borough account. Mr. Wolak said that at the last Public Celebrations Committee meeting it was discussed that the Borough may be able to front her the money so that she wouldn't have to be out of pocket all that money by herself. Ms. Rhodes said that is where she needs clarification because she was seeking the businesses to front the money. Mayor Anesh clarified that she in fact is not seeking the Borough to front the money but in fact, have the businesses do it. Ms. Rhodes said yes. Mayor Anesh said if he were to write out a check who would it be written out to. Ms. Rhodes said the Borough of South Plainfield. Mayor Anesh said assuming it's not the Borough of South Plainfield who is the check written out to; her or Colonial Flag? Ms. Rhodes said it can be to her because Colonial Flag is a 501C3. So Mayor Anesh asked again; it would be written out to Colonial Flag. Ms. Rhodes said no we don't want it to go to Colonial Flag but to someplace in South Plainfield so that we can ultimately cut a check to the South Plainfield food pantry. Mr. Rizzo said we need a definitive plan and needs to see something in writing and to be clear on what we are and are not doing. Mr. Rizzo said this is the first time he is hearing about all of this. Councilman White suggested at this point, Ms. Rhodes and Public Celebrations meet again to discuss this and keep Paul in the loop. Everyone agreed.

Darleen Cullen of Fox Place said she thinks this is a great program but is confused by muddying the waters with Public Celebrations when Mrs. Boyle who just stood up and clarified that she is a bona fide 501C is here and could easily partner with Ms. Rhodes. Mrs. Cullen expressed concerns about setting a precedent with other organizations using Public Celebrations for all their events.

With no further comments from the public, Mayor Anesh closed the floor.

At 7:56 p.m. Mayor Anesh called for a recess from the public portion of the meeting to go into Executive Session advising that everyone is welcome to stay if they choose.

Upon return from Executive Session at 8:42 p.m., Mayor Anesh called the public meeting back to order.

## **ADJOURNMENT**

Without further comment and no more action necessary for this evening, Mayor Anesh called for a motion to adjourn. Councilman Richkus made a motion to adjourn at 8:42 p.m., seconded by Councilman Rusnak and unanimously carried. The meeting was adjourned.
