COUNCIL REPORTS:

Borough Attorney Paul Rizzo - reported progress.

Administrator Cullen – said that last week the added and omitted bills were sent out. It is the largest added and omitted bill we've had since 2007. We expect to see an increase in our ratable base at the end of 2019. The demolition of the pool has begun and the line is removed. Nixel alerts have gone out pertaining to the emergency sewer main repair on New Brunswick Avenue. They are hoping it will take 4-5 days for the repair to be completed.

<u>Engineer Miller</u> – advised that he has been gathering quotes to repair the lighting at Memorial Park and hopes to have them by the end of this week.

<u>Clerk Antonides</u> – we held our annual poll worker training class at the Senior Center on October 17th. It was a big success and the County is very please with this location for the training as it generates a lot of trainees. Also next year the County is planning on rolling out new touch screen voting machines, so more training will be taking place for this purpose.

<u>Councilman Vesce</u> – gave a shout out to everyone involved with Saturday's Fall Festival. It was a tremendous turnout. It was very well done and the volunteers are to be congratulated.

Councilwoman Faustini — Echo Councilman Vesce's comments regarding the Fall Festival, it was wonderful, and thanks also goes to the Library. On November 9th the Public Celebrations Committee will be hosting an alternate celebration due to the fact of not having the Labor Day Parade this year, it will be an event to honor Veteran's. It will begin at Monument Park and end at Veteran's Park. The Cappi Awards will be held on November 16th honoring Georgeanna Cochran at 6:30 p.m. at the Senior Center. Basketball and Wrestling sign-ups are still under way. Councilwoman Faustini congratulated everyone who decorated a scarecrow outside and thanked all who participated.

Councilman Bengivenga – said that last week something came to his attention and asked Councilman Dean about a house that was built on Clark Lane that he mentioned a couple months ago, the one that had a fire, saying that he had stated the drainage was from next door and that the neighbor complained saying the water was running off because they had increased the elevation. Councilman Bengivenga expressed his concern when he saw that Councilman Dean's company did the final grading. Councilman Dean said the issue was before we did the final grading. The neighbors were complaining asking why the house was allowed to be built out further from the ground than the existing property lines. Councilman Bengivenga said you brought that claim to the officials of the Borough, you met with the property owners prior to bringing it to the attention of the Borough officials and then you got the job. Councilman Dean said no, he had the job for building steps and the other contractor was supposed to do the other work but backed out of it and as a result the property owner than asked Councilman Dean to do the job. Councilman Dean reiterated, he did not have that job and did not come to the Borough and do something to try to abuse power to solve an issue. The fireman next door approached him and asked him how this home can be built out of the ground higher than it was originally. Councilman Dean said when asked he said that he doesn't know to call the town and ask them. Councilman Bengivenga said the point is that he got the contract to do the job and regrade the property. Councilman Dean said that was after the fact. Councilman Bengivenga asked if he sees a problem with him making a complaint to the Borough and then doing the job. Councilman Dean said he didn't make a complaint to the Borough he just asked if there was a reason why the house was allowed to be built the way it was. Councilman Dean said if he were to make a complaint, he would have made a bigger deal out of it asking how they were allowed to build this house and not remove any dirt off the site. Councilman Bengivenga said that he did ask Mr. Cullen to investigate this matter and after the fact got the contract to grade the property. Councilman Dean said he fixed it. Councilman Bengivenga said that is the point, he can not use his Council position to take

a job. Councilman Dean said he was not using his Council position, he was doing something a neighbor asked him to look into. Councilman Dean said that he never said he is on Council so let's go complain to the town and then try to pick-up a \$2,500 grading job. Councilman Bengivenga then said that both last year and this year he had made a complaint about Dollar General and their weeds, and then went and cleared out the weeds. Councilman Dean said he can't stop a business from calling him. Councilman Bengivenga said the whole point is that you're making a complaint to the Borough and then taking the job. Councilman Dean said he is followingup with a complaint. Councilman Bengivenga said it doesn't matter you can't take on the job and asked Mr. Rizzo Esq. to explain what the ethics laws are in New Jersey because you can not use your position on Council to make a complaint and then get a job regardless if they call you or not. Councilman Dean said his business has been in this town for 15 years and can't stop someone from calling him. Councilman Bengivenga said you made the complaint to John Abbruzzese about the weeds at Dollar General then your company took the job. Councilman Dean said he didn't handle Dollar General his business partner did. Councilman Bengivenga said the point is you made the complaint to John Abbruzzese about the weeds and then your company took the job. It's a financial gain. Mayor Anesh said that he doesn't think Councilman Dean intentionally did something wrong, however, clearly the appearance looks bad. Mayor Anesh said that people in our town will come to us when there is an issue and Councilman Dean has a bit more exposure to it when dealing with these types of complaints hence inadvertently you could end up getting a job. Councilman Bengivenga said he needs to learn how to recuse himself, for example, he just voted on authorization for a tax judgement refund for 50 Cragwood Road who's partnered with Friendwell who you do all the landscaping for. Councilman Dean said that Councilman Bengivenga handles the trash removal for them too. Councilman Bengivenga said he does not, nor does his company; Republic. Councilman Dean said he believes Councilman Bengivenga has a good relationship with Jason who owns Friendwell. Councilman Bengivenga said yes, he knows Jason, however he does not financially benefit from Jason. Councilman Dean said but your company does. Councilman Bengivenga said no they don't, they do one hotel for them of which he does not represent. Councilman Bengivenga said the point is, you should recuse yourself. Mr. Rizzo said the state statute says you can not use your position to gain unwarranted privilege or advantage. There's another section which says you can use information you've obtained to gain a financial advantage. If it's a situation where you cause a complaint and the property owner is then told they have to do something, and you went to the property owner than that would be a problem. The code of ethics does provide that you have to avoid conflict and appearance of a conflict. Councilman Dean said he wasn't the only one with Dollar General to make a complaint, John Abbruzzese said he had received numerous complaints and said he can't stop a company from calling him. Mr. Rizzo said that perhaps you should say that you shouldn't be involved in it. Mr. Rizzo said his philosophy has always been that if there is a question or any doubt, don't do it and avoid it. Councilman Bengivenga said that's his point. Mr. Rizzo said that you can also always ask the Local Finance Board if there is a question in this regard for their opinion.

Councilman Dean - reported progress.

Councilman White – was absent this evening.

<u>Council President Wolak</u> – said his thoughts and prayers go out to Councilman White's family dealing with the loss of his mother.

Mayor Anesh – reported progress.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment.

With no comments from the public, Mayor Anesh closed the floor at 7:27 p.m. and announced that we are going into a closed session meeting and everyone is welcome to stay if they wish.

Without further comment and no more action necessary for this evening Mayor Anesh called for a motion to adjourn. Councilman Bengivenga made a motion to adjourn at 7:39 p.m., seconded by Councilwoman Faustini and unanimously carried. The meeting was adjourned.
