Review of Agenda Items: Clerk Antonides reviewed all the items on the agenda advising there is the addition of two proclamations; Autism Awareness and National Library Week as well as the addition of resolution 21-141. Mayor Anesh called for a motion to add the two proclamations as well as resolution 21-141 to this evening's agenda.
