COUNCIL REPORTS:

Borough Attorney Paul Rizzo – reported progress.

Administrator Cullen — explained the purpose of resolution 21-312 regarding the storm sewer emergency on South Central Avenue that was added to the agenda this evening, saying that it was from a PSE&G job in which they came across some crumbling pipe. Mr. Cullen pointed out that the Best Practices is also on tonight's meeting in which our total score is an 18. We ae compliant in most everything, though certain areas are not applicable to us. These Best Practice scores can have an impact on some state aid funding, however, there will be no impact with our score. Mr. Cullen concluded by advising that we will be going out to market soon with our general improvement bonds.

<u>Engineer Miller</u> – advised that the Metuchen Avenue road improvements will begin the concrete work this week and the milling and paving will begin next week. Mr. Miller concluded by advising that leaf collection is beginning to take place now.

<u>Clerk Antonides</u> – reported progress.

Councilman Smith – thanked the Library Board for all their work with the recent pumpkin patch event and said he hopes the media will also acknowledge it because it was very nice what they did.

<u>Councilwoman Mott</u> – reported progress.

<u>Councilman Wolak</u> – Concurred with what Councilman Smith said about the recent Library Fall Festival this past weekend. The weather was great for it and they did a great job. Councilman Wolak went on to report progress.

Councilman Bengivenga – wished Councilwoman Mott a very happy birthday and then went on to report progress.

Councilwoman Faustini — advised that basketball and wrestling sign-ups ae still taking place. The trunk or treat event will be held on Halloween this year in Veteran's Park and you can sign-up on Community Pass in advance if you wish to attend. The hours are from 12:30 to 4:00 p.m. with 12:30 to 1:00 pm geared for those with special needs. They are still seeking volunteers and candy donations. Councilwoman Faustini concluded by thanking both the schools and Board of Education for their recent contribution to Social Services for Storm Ida victims.

Council President White – advised that LA Finesse has begun work and then went on to report progress.

<u>Mayor Anesh</u> – advised that the County has a total of 270 more Covid cases reported with a grand total to date of 104,378. South Plainfield had 5 more cases reported with a total to date of 3,283. Mayor Anesh reminded everyone that vaccinations ae still available and encouraged everyone to continue to protect themselves.

COMMENTS FROM THE PUBLIC:

Mayor Anesh opened the floor for public comment reiterating the aforementioned remote directions for making remote public comment.

Carol Christatos of 2305 Selene Avenue voiced reaffirmed her complaints regarding 2301 Selene Avenue from the last Council meeting saying she is disappointed that no one has reached out to her yet. Ms. Christatos advised of an article she found disappointing and distressing pertaining to a reduction of property values when you have a vacant or abandoned home near you and is very concerned about her and her neighbor's property values. Mr. Cullen advised he spoke to the Zoning Officer, Property Maintenance Officer and Construction Official about this and when he went to look at it, the house looks fairly new with new windows and siding. Ms. Christatos said there are several holes in the roof and side of house and said that animals are getting in. Mr. Cullen advised that the Construction Official has been in contact with the owner and that he and the Code Enforcer inspected this property. All the permits are currently expired and will require new ones to continue the work on this house. Ms. Christatos repeated that the holes are still there, and something needs to be done. Mayor Anesh said they will send our officials back out tomorrow to reinvestigate. Mr. Rizzo Esq. said from a legal standpoint there is nothing that can be done at this point. It is all up to the officials. Mr. Cullen said he will go back out again and look at it himself and will absolutely contact Ms. Christatos as to the status of the officials investigations.

Leon Gwiazdowski of 2309 Selene Avenue also readdressed his concerns from the last meeting saying he walks around the property all the time and that the power is turned off, and there is water in the basement and an odor around the property with holes in the roof. Mayor Anesh and some Council members expressed that they would speak to our Construction Official and Zoning Officer again about it. None of them said that there were any issues with water or odor around the property after their last inspection a week or two ago.

Gary and Susan Romeri of 2300 Selene Avenue asked what the definition of abandoned is.

Terry Alexa of 2800 Maple Avenue complained about seeing an "infinity" vehicle "from the area" with a gentleman that opens the front door with a key. Mrs. Alexa complained that her husband, Donald, had to kill a rat that was found in their garage, indicating this vacant house was responsible for that and then went on to say she feels this issue is being brushed under the rug and is very concerned for their property values.

Mr. Rizzo Esq. responded by saying that by Mrs. Romeri's own admission, the house is not abandoned if she is seeing someone enter the front door with a key.

Mr. Donald Alexa asked how they will be notified of the outcome of the officials' inspections. Mr. Cullen said he will contact Carol Christatos with an update, as she appears to be the spokeswoman of your group.

Debbie Boyle of Van Fleet thanked Tree Olano for accepting on behalf of Heather Barry all the storm Ida donations and Ms. Boyle went on to advise how to enter the scarecrow contest.

Miriam Rizvi advised that her assignment from school requires her to ask question(s) pertaining to a governing body agenda. Ms. Rizvi asked if all police officers are required to wear them and how many of there are there. Chief Parker who was in the audience advised that there are 62 officers and yes, they are all required to wear them.

Without further comment from the public, Mayor Anesh closed the floor from the public.

ADJOURNMENT
Without further comment and no more action necessary for this evening Mayor Anesh called for a motion to adjourn. Councilman Smith made a motion to adjourn at 7:50 p.m., seconded by Council President White and unanimously carried. The meeting was adjourned.
